Standard warranty provisions apply:

1. The Supplier warrants that the goods supplied under the contract are new (unused) and with the technical specifications required by the Basilan General Hospital. The Supplier warrants the timely delivery of the items. Any delay or failure to deliver may result in termination of the contract and blacklisting of the entity.
2. The Supplier further warrants that all Goods supplied under this contract shall have no issue or defect arising from the design, materials or workmanship or from any act or omission of the Supplier that may develop under normal use of the supplied Goods in the conditions prevailing in the country of final destination.



3. In order to ensure that any manufacturing defects shall be corrected by the Supplier a warranty shall be required from the Supplier for a minimum period of three (3) months. The obligation for the warranty shall be covered by, at the Supplier option, either retention money or bank guaranty in an amount equivalent to at least one percent (1%) of every progress payment. If the latter is opted, the same shall be submitted three days upon conclusion of negotiations and before the issuance of the Notice of Award and Contract Agreement. Failure to submit stated warranty security shall automatically revert the warranty security to the option of retention money.
4. The Basilan General Hospital shall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall, within the period specified and with all reasonable speed, replace the defective Goods without cost to the Procuring Entity.
5. The Basilan General Hospital shall be allowed to deduct Twelve Percent (12%) Value Added Tax (VAT) charged by the Philippine Government from the purchase price. In the event that the Supplier or the Basilan General Hospital shall be deemed to be exempt from the payment of VAT on the purchased items to the Republic of the Philippines, the amount will not be refunded to the Supplier.
